The Directors of The Muslim Jewish Forum of Greater Manchester present their annual report together with the financial statements for the year ended 31 March 2021.

**Our purpose**

The objects for which the Forum is established are to develop the cultural and social ties between the Muslim and Jewish Communities of Greater Manchester; to educate members of the Muslim and Jewish Communities in relation to their shared values and common Abrahamic tradition, heritage, history and culture; and to promote better understanding within the wider community of the interests and values that are common to the Muslim and Jewish Communities.

**Principal activities during the year**

During the year, the Forum was unable to hold any in-person events due to the coronavirus pandemic.

However, by using Zoom, the Forum was able to hold 11 online events to further our objects, as listed below. This is more than we would normally have in a year of physical events. Furthermore, recording our events enabled us to publish appropriate parts on our website. They can all be found via our "News and past events" page.

12 April 2020 – "Muslims, Jews and COVID-19." Mohammed Amin gave a 19-minute presentation which was followed by a 70-minute participants' discussion facilitated by Jonny Wineberg who took notes that were published on our website as well as the presentation recording.

26 April 2020 – "Muslims, Jews and keeping healthy during the COVID-19 crisis." Former Executive Committee Member Doctor Jackie Lewis, who is a retired GP, gave a presentation focusing on healthy eating and exercise.

31 May 2020 – "Has the COVID-19 crisis strengthened or weakened people's faith?" Solicitor Jawad Amin from Khizra Mosque gave a Muslim perspective, and Cllr Rabbi Arnold Saunders gave a Jewish perspective.

14 June 2020 – The Forum celebrated its 15<sup>th</sup> Anniversary. Co-Founder Afzal Khan CBE, MP for Manchester Gorton spoke alongside Mark Guterman, eldest son of our late Co-Founder Henry Guterman MBE. An in-person celebration is planned for 3 October 2021.

19 July 2020 – Commemoration of the 25<sup>th</sup> Anniversary of the Srebrenica Genocide. We had six speakers including Kate Green MP for Stretford and Urmston, and Aldin Zilic, who came to the UK as a refugee from Bosnia aged nine.

15 November 2020 – "What I like about Religion X." To mark the UK's national Interfaith Week, a Muslim spoke about Judaism, a Jew spoke about Christianity, and a Christian spoke about Islam.

29 November 2020 – "Combating Islamophobia Together." This event was organised jointly with the British Muslim Heritage Centre to mark Islamophobia Awareness Month.

15 December 2020 – We held an online Chanukah celebration including performances of klezmer music.

31 January 2021 – "Muslims and Jews on the medical, legal and religious aspects of organ donation." To illustrate the benefits of online events, our speakers were a transplant surgeon from London, an imam from Cardiff and a rabbi from London, all of whom had specialist expertise on this topic.

28 February 2021 – "Purim Fancy Hat Party." We held our first ever Purim party, with all participants wearing a fancy hat. As well as David Berkley telling the story of Purim, we were entertained by klezmer music and two comedians.

21 March 2021 – “Anglo-Jewry’s interactions with converts to Islam in the period 1900-1920.” Robert Kanter shared with us part of his PhD thesis research, covering British Jewry’s relationship with William Henry Quilliam and Marmaduke William Pickthall.

**Financial accounts**

The financial accounts, which comprise an Income and Expenditure Account and a Balance Sheet, are set out on the following pages. Due to the small size of the company’s turnover and assets, the accounts are not required to be audited.

During the year, the Forum had total receipts of £533.00 and total expenditures of £586.75 resulting in an overall deficit of £53.75 as detailed in the Income and Expenditure account.

The overall financial position is considered satisfactory.

**Charitable status**

The Forum is registered as a charity with HM Revenue & Customs with effect from 9 May 2014. Accordingly, donors to the Forum who are taxpayers are requested to complete a gift aid declaration which can be downloaded from the “Join us” section of our website. Donors to the Forum who are higher rate taxpayers should be able to claim higher rate tax relief through self-assessment for their donations.
