The Directors of The Muslim Jewish Forum of Greater Manchester present their annual report together with the financial statements for the year to 30 June 2009.

Principal Activities

The objects for which the Forum is established are to develop the cultural and social ties between the Muslim and Jewish Communities of Greater Manchester; to educate members of the Muslim and Jewish Communities in relation to their shared values and common Abrahamic tradition, heritage, history and culture; and to promote better understanding within the wider community of the interests and values that are common to the Muslim and Jewish Communities.

During the period, the Forum has held a number of events to further these objects. They included:

6TH JULY 2008 We held a picnic jointly with the Christian Muslim Forum in Heaton Park. It was well attended by approximately 30 people.

31st AUGUST 2008 We held an informal afternoon tea at the Midland Hotel. This was well attended by over 20 men, women and children.

12th OCTOBER 2008 We held a post Eid Party at Al Khizra Mosque on Brideoak Street, Cheetham. Vegetarian Indian food was served.

12th NOVEMBER 2008 We held our 3rd Lawyers and Accountants meeting entitled "Muslim and Jewish Business Ethics". Dayan Berger and Imran Azam gave presentations and the meeting was hosted by Linder Myers Solicitors.

14th DECEMBER 2008 We held a Xmas/Eid/Chanucah party jointly with the Christian Forum and the Council for Christians and Jews at Jacksons Row Synagogue. Around 200 people attended this Event and Hazel Blears addressed the audience.

22nd FEBRUARY 2009 We held a "Gaza/Israel Listening Event" at the Town Hall in which 11 Jewish people and 11 Muslim people talked about how they felt about the current situation in the region. The Event was chaired by Jane Clements of the Forum for the Discussion of Israel and Palestine.

8th MARCH 2009 We held an event titled "Once Upon a Time in Manchester" to celebrate International Women's Day at the Town Hall. This was a creative workshop organised by Laura Nathan and it was attended by approximately 20 Jewish and Muslim women.

29th MARCH 2009 We held another informal afternoon tea at the Midland Hotel.

19th-21st MAY 2009 Six members of the Forum went on a moving and eventful excursion to Auschwitz and Poland.

23RD JUNE 2009 We held our 4th Lawyers and Accountants Event entitled "The Role of Religious Courts in the UK today". Rabbi Yehuda Brodie and Qamar Bhatti gave presentations and the Event was hosted once more by Linder Myers Solicitors. The Event was attended by approximately 40 people.

30th JUNE 2009 Members of the committee participated in a meal at J.S. Kosher restaurant.

We also supported other organisation's events:

10th AUGUST 2008 Both our Co Chairs, Cllr Afzal Khan CBE and Jonny Wineberg gave presentations to over 300 people at the Adam Day multi-faith event.

23rd NOVEMBER 2008 We entered a team in the Jewish Rep Council's Community Quiz at Bowden Synagogue. We came 8th in this quiz.

30th MARCH 2009 Our co-chairs, Cllr Afzal Khan CBE and Jonny Wineberg gave a joint presentation at an event at Lambeth Palace organised by the UK Interfaith Network.

24th MAY 2009 Mohammed Amin and David Berkley Q.C. gave a novel presentation about Jerusalem at Manchester Limmud.
