The Directors of The Muslim Jewish Forum of Greater Manchester present their annual report together with the financial statements for the year ended 31 March 2020.

Principal Activities

The objects for which the Forum is established are to develop the cultural and social ties between the Muslim and Jewish Communities of Greater Manchester; to educate members of the Muslim and Jewish Communities in relation to their shared values and common Abrahamic tradition, heritage, history and culture; and to promote better understanding within the wider community of the interests and values that are common to the Muslim and Jewish Communities.

During the year, the Forum has held a number of events to further these objects:

- 10 April 2019 We co-hosted the VIP launch of a new exhibition brought by International Christian Embassy Jerusalem ("ICEJ") / Yad Vashem travelling exhibitions depicting Albanian Muslims who saved Jews in the Second World War. Guest speakers included exhibition co-ordinator Russell Bowles, Rabbi Warren Elf and Ceremonial Mayor of Salford Cllr Ronnie Wilson. Approximately 20 people attended.
- 19 May 2019 We held our annual Iftar at Khizra Mosque. The speakers included Graham Stringer MP, Afzal Khan CBE MP, Rabbi Dr Reuven Silverman and the Dean of Manchester Cathedral the Very Reverend Rogers Govender. Approximately 50 people attended.
- 23 June 2019 We held our first Migration Stories event at the British Muslim Heritage Centre. The speakers were Forum Co-Chair Mohammed Amin, Afzal Khan CBE MP, Cllr Amna Abdul, Anne Isaac, Forum Co-Chair Cllr Heather Fletcher, Dr Jacqueline Lewis, Jacky Buchsbaum and Jay Charara. Approximately 25 people attended. The talks were recorded and can be heard on the Forum's website.
- 4 August 2019 We held our annual picnic at St. Mary's Park in Prestwich with approximately 30 people attending.
- 6 October 2019 We organised a day trip to Lincoln, the city which in 1255 saw one of the earliest cases of the "Blood libel." We had a vegetarian meal and then visited the Lincoln Cathedral and locations of Jewish interest. In Jews Court Richard Dale of the Lincoln Jewish community told us about the recent growth of the Jewish community in Lincoln, and Lincoln's nascent Muslim community. 16 people went on the trip.
- 31 October 2019 We held our annual "Loose Lawyers" panel event at Khizra Mosque. The question for the evening was "Should the Government have the power to take away my citizenship?" The panel consisted of barristers Ahmed Nadim and David Berkley QC, and solicitors Joanne Feldman and Nasir Hafezi. Approximately 50 people attended.
- 5 November 2019 We co-hosted a VIP launch of another new ICEJ exhibition entitled "Children of the Holocaust" at Broughton Hub. Speakers included Rabbi Warren Elf, exhibition co-ordinator Russell Bowles, the deputy City Mayor of Salford Cllr John Merry, and the Ceremonial Mayor of Salford Cllr Charlie McIntyre. Approximately 25 people attended.
- 9 February 2020 We held our annual kosher meal at Pagoda Chinese Cuisine & Grill kosher restaurant with our special guest being the High Sheriff of Greater Manchester Mark Adelstone OBE DL. Approximately 22 people attended.

The Forum also organised joint events with other interfaith organisations and supported other organisations' events. Some of these are listed below:

10 August 2019 - Co Chair Cllr Heather Fletcher spoke at the 17th Adam Day event in Manchester.

11 March 2020 – Both Co-Chairs Cllr Heather Fletcher and Mohammed Amin explained the history and mission of the Forum to students at Salford University's Faith Centre at the invitation of the University's Muslim Chaplain Imam Rashid Musa. The presentation was recorded and can be watched on the Forum's website.

Financial Accounts

The financial accounts, which comprise an Income and Expenditure Account and a Balance Sheet, are set out on the following pages. Due to the small size of the company's turnover and assets, the accounts are not required to be audited.

During the year, the Forum had total receipts of £2,250.12 and total expenditures of £679.34 resulting in an overall surplus of £1,570.78 as detailed in the Income and Expenditure account.

The overall financial position is considered satisfactory. The size of the surplus is due to receiving two annual grants from the Foundation for Ethnic Understanding within one accounting year.

Charitable status

The Forum is registered as a charity with HM Revenue & Customs with effect from 9 May 2014. Accordingly, donors to the Forum who are taxpayers are requested to complete a gift aid declaration which can be downloaded from the "Join us" section of our website. Donors to the Forum who are higher rate taxpayers should be able to claim higher rate tax relief through self-assessment for their donations.
